**Hamilton County's Child Support Enforcement Agency
Issues New Monthly Most Wanted**

Cincinnati (June 4, 2007) A father who owes more than \$40,000 to his three children is Hamilton County's latest monthly Most Wanted Deadbeat Parent.

Danny Hallwood, 34, owes at least \$40,830 in delinquent child support. Hallwood's previous occupation was in fast food, and his last known address was Columbia Avenue in Cincinnati.

He is the latest parent to be depicted in Hamilton County's Child Support Enforcement Agency's new monthly Most Wanted posters. The agency issues a Most Wanted poster each year depicting eight parents who owe large arrearages in child support. The county has received so much interest in participating in the annual posters that it decided to also issue one Most Wanted parent every month.

"It's wildly popular with our parents because it is so successful," said Jeffrey Startzman, assistant director of the county's Child Support Enforcement Agency, a division within the Department of Job and Family Services. "For many parents trying to raise their children, it is the last-ditch effort to find the absent parent and get some help. We had such great demand to participate that we wanted to give more people the opportunity."

Most Wanted posters include the person's photo, name, age, last-known address and occupation, number of children and amount owed.

The Department's Child Support Enforcement Agency handles about 95,000 cases right now. Last year, it collected \$155 million for families that might not otherwise have had the financial support necessary to pay for such items as food, medical care, child care, school clothes and school supplies. Many of the children who do not receive child support turn to public assistance, with taxpayers providing financial support.

To appear on a monthly Most Wanted poster, the parent with custody of the children must sign a waiver. In addition, a person must have a warrant for failure to appear in court, something that occurs when the absent parent does not appear in court on the contempt motion filed by the Support Enforcement Agency to enforce the order.

The Child Support Enforcement Agency sent the posters to government agencies, police departments, community partners, post offices and tax preparation services throughout the Tristate area.

In addition to the Most Wanted poster, Hamilton County Child Support uses a variety of tools to collect child support, including freezing and seizing funds from bank accounts, intercepting tax refunds and suspending licenses.

Anyone who knows the whereabouts of someone on the poster can call the Sheriff's Office at 946-5350. Also, more parents wanted for failing to pay child support can be found at www.hcso.org. Choose Deadbeats from the Public Services menu. Tipsters can remain anonymous.
