**Hamilton County's Child Support Enforcement Agency  
Issues Monthly Most Wanted**

**Cincinnati (Nov. 4, 2008)** A father who owes nearly \$78,000 to his two children is Hamilton County's latest monthly Most Wanted Deadbeat Parent.

Chilton Turner Jr., 42, was last known to live on Danvers Drive in Cincinnati.

He is the latest parent to be depicted in Hamilton County's Child Support Enforcement Agency's monthly Most Wanted posters. The posters are complements to the annual Most Wanted Poster, which depicts eight different people who are delinquent on child support.

"Our monthly Most Wanted are just one of the many tools we use to help us collect the financial support owed to Hamilton County's families and children," said Moira Weir, director of the Hamilton County Department of Job and Family Services, which includes the Child Support Enforcement Agency. "We need to do everything possible so they don't have to go it alone or become a burden to taxpayers. If you bring a child into this world, you have a responsibility to that child."

Most Wanted posters include the person's photo, name, age, last-known address, number of children and amount owed.

The Department's Child Support Enforcement Agency handles about 92,000 cases right now. Last year, it collected \$142 million for families that might not otherwise have had the financial support necessary to pay for such items as food, medical care, child care, school clothes and school supplies. Many of the children who do not receive child support turn to public assistance, with taxpayers providing financial support.

To appear on a monthly Most Wanted poster, the parent with custody of the children must sign a waiver. In addition, a person must have a warrant for failure to appear in court, something that occurs when the absent parent does not appear in court on the contempt motion filed by the Support Enforcement Agency to enforce the order.

The Child Support Enforcement Agency sent the posters to government agencies, police departments, community partners, post offices and tax preparation services throughout the Tristate area.

In addition to the Most Wanted poster, Hamilton County Child Support uses a variety of tools to collect child support, including freezing and seizing funds from bank accounts, intercepting tax refunds and suspending licenses.
