**Grant Name:** Technical Assistance and Dissemination To Improve Services and Results for Children With Disabilities, CFDA # 84.326E

**Funder:** US Dept of Education, Office of Special Education and Rehabilitative Services.

**Eligibility:** State educational agencies (SEAs), local educational agencies (LEAs), public charter schools that are LEAs under State law, institutions of higher education (IHEs), other public agencies, private nonprofit organizations, outlying areas, and for-profit organizations.

**Award Range/Funding Period:** 1 award will be granted for up to 60 months; your request may not exceed \$2.83MM.

**Summary:** This program promotes academic achievement and improves results for children with disabilities by supporting technical assistance, model demonstration projects, dissemination of useful information, and implementation activities that are supported by scientifically-based research.

**Grant Name:** AdoptUsKids,

**Funder:** US Dept of

**Eligibility:** Non-profits with 501(c)(3) IRS status (other than institutions of higher education), non-profits without 501(c)(3) IRS status (other than institutions of higher education), private institutions of higher education. Faith-based and community organizations that meet the statutory eligibility requirements are eligible to apply under this announcement. Applicants must demonstrate experience in child welfare, foster home development, and adoption services. The Children's Bureau will accept applications that represent partnerships among organizations with relevant experience. Applicants may subcontract with organizations specializing in their assigned tasks. Applications from collaborations must identify a primary applicant responsible for administering the cooperative agreement.

**Award Range/Funding Period:** 1 award will be granted for a 60-month project period, first 12 months' award not to exceed \$3,669,500.

**Summary:** The purpose of this program announcement is to establish, by awarding a cooperative agreement, a multi-faceted national AdoptUsKids program designed to assist States and Tribes in the recruitment and support of foster and adoptive families for children in public foster care. AdoptUsKids will:

- Provide training and technical assistance to States and Tribes regarding the recruitment, including interjurisdictional recruitment, of foster and adoptive families for children who require these services.
- Maintain a National Adoption Internet Photolisting Service (currently operating as AdoptUsKids).
- Operate a National Adoption Information Exchange System that helps locate and recruit prospective adoptive parents for the adoption of children from foster care and assists in making connections between the public and private agencies that may be involved in achieving these adoptions within and across jurisdictions.
- Plan, carry out, and assist States and Tribes to carry out fulfillment activities in response to a national multi-media adoptive and foster home recruitment campaign.

**Grant Name:** Lead Hazard NOFA (combines 3 lead programs: (1) Lead-Based Paint Hazard Control Grant

Program, (2) Lead Hazard Reduction Demonstration Grant Program, and (3) Operation Lead Elimination Action Program), CFDA #'s 14.900, 14.905, 14.903.

**Funder:** US Dept of HUD, Office of Healthy Homes and Lead Hazard Control

**Eligibility:** To be eligible to apply for funding under the Lead-Based Paint Hazard Control (LBPHC) Grant Program, the applicant must be a state, city, county, or other unit of local government. Multiple units of a local government (or multiple local governments) may apply as a consortium; however, you must identify a lead applicant that will be responsible for ensuring compliance with all requirements specified in this NOFA. State government applicants must have an Environmental Protection Agency (EPA) authorized lead-based paint training and certification program. To be eligible to apply for the Lead Hazard Reduction Demonstration (LHRD) Grant Program, the applicant must be a city, county, or other unit of local government. The applicant must have at least 3,500 pre-1940 occupied rental housing units, as listed at the 2000 Census Web site identified in Form HUD 96013, Need/Extent of the Problem. In addition, a State may apply on behalf of one or more of the eligible local jurisdictions if it has an EPA-authorized lead-based paint training and certification program. A list of eligible applicants can be downloaded with the application from [www.grants.gov/Applicants/Apply\\_for\\_grants.jsp](http://www.grants.gov/Applicants/Apply_for_grants.jsp) in Appendix A. To be eligible to apply for funding under the Operation Lead Elimination Action Program (LEAP), the applicant must be a non-profit or for-profit entity or firm. For-profit institutions are not allowed to earn a fee. Colleges and Universities are also eligible to apply. National and local groups are encouraged to apply. States, cities, counties and units of local government and their departments are not eligible.

**Award Range/Funding Period:** approximately \$76.4 million will be available for the Lead-Based Paint Hazard Control Program, approximately \$54.7 million will be available for the Lead-Based Paint Hazard Reduction Grant Program, and approximately \$17.3 million will be available for Operation Lead Elimination Action Program..Approximately 26 to 40 grants will be awarded to applicants for the Lead-Based Paint Hazard Control Program. Approximately 14 to 22 grants will be awarded to applicants for the Lead Hazard Reduction Demonstration Program, and approximately 9 to 12 grants will be awarded to applicants for Operation Lead Elimination Action Program. Grant award amounts for the entire period of performance for Lead-Based Paint Hazard Control Program grants shall be from approximately \$1 million up to a maximum of \$3 million per grant, for the Lead Hazard Reduction Demonstration Program grants, from approximately \$1 million up to a maximum of \$4 million per grant, and for Operation Lead Elimination Action Program (LEAP) grants a maximum of \$2 million per grant. THE PROJECT PERIODS FOR ALL THREE GRANTS WILL NOT EXCEED 36 MONTHS.

**Summary:** The purpose of the Lead-Based Paint Hazard Control Program is to assist states, Native American Tribes, and local governments in undertaking comprehensive programs to identify and control lead-based paint hazards in eligible privately owned housing for rental or owner-occupants. b. The purpose of the Lead Hazard Reduction Demonstration Grant Program is the same as the Lead-Based Paint Hazard Control, but the Lead Hazard Reduction Demonstration Grant Program is targeted for urban jurisdictions with the highest lead-based paint hazard control needs. c. The purpose of the Operation Lead Elimination Action Program is to provide grants to private sector and nonprofit organizations to leverage funds for addressing lead hazards in privately owned housing units and eliminating lead poisoning as a major public health threat to young children.
